2019 WAIVER

Acknowledgement

I certify that I know that either running a trail race, or venturing out on a nature walk, is a potentially hazardous activity and that I should not register and participate unless I am medically able and properly trained. I agree to abide by any decisions of the Allerton Park Trail Run race officials relative to my ability to safely complete the event, and I understand I must follow the directions of race volunteers such as course marshals or first responder personnel. I certify I understand there may be areas of the trail run or nature walk that are especially rugged and/or may be on sparsely marked terrain. I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event. I certify I assume all risks associated with walking or running in this event including but not limited to becoming lost, illness from animals or plants, and injuries or death from: falls, contact with other participants, the effects of weather (including high heat and/or humidity, extreme cold and/or wind chills, high winds, lightning, snow, and ice), traffic, and or conditions along the trail (including flooding, mud, tree roots, rocks, water crossings, hills, and steps) all such risks being known and appreciated by me. I further acknowledge that the organizers reserve the right to refuse or revoke my registration into the event for any reason including safety or acts of God and/or nature. I understand that the registration fees I paid are non-refundable and non-transferable to another person or entity.

Covered Entities

Having read this waiver and knowing these facts and in consideration of your accepting my registration, I the undersigned, intending to be legally bound, hereby for myself, my dependents within this form for which I asserted guardianship and/or supervision over, my heirs or executors and administrators, and anyone entitled to act on my behalf waive and release any and all rights and claims for damages I may have against the Allerton Park Trail Run (including RRCA Certified Race Director Jim Fair III, Race Captains, event volunteers, assignees, and successors of the race), the Second Wind Running Club, the Road

Runners Club of America, Racer Pal, Body'N Sole Sports, the City of Monticello, the University of Illinois (and its Board of Trustees), John & Mary E. Kirby Hospital, all sponsors and any other supporters and their representatives, from any and all claims or liabilities of any kind arising out of my participation in this event or carelessness on the part of organizations or persons named in this waiver. I understand this waiver is separate from the Racer Pal terms of use. I attest and certify that I am physically fit and have sufficiently trained for the completion of the event. I am aware that the foregoing organizations assume no liability in the event this event is cancelled or courses rerouted for any reason. Although I am free to request approval of a transfer request from one component of this event to another (such as from the Nature Walk to the Trail Run or vice versa) for myself, my dependent for which I am a parent or guardian, or on behalf of my sponsoring organization on or before any communicated deadline, all decisions communicated by the Race Director, Race Captains, or their designees and assignees are final.

Permissions & Severability Clause

In the event of a conflict decisions by a Race Captain supersedes decisions communicated by designees and assignees while decisions from a Race Director supersedes all other decisions. However, decisions made by first responders and emergency personnel must be adhered to at all times.

Further I grant permission to all the foregoing to use my name and images or video of myself in any photographs, surveys, social media promotions, webcasts, motion pictures, results, publications, or any other print, video graphic, and/or electronic record such as a broadcast, telecast, or other written account of this event for legitimate purposes. I further expressly agree that this Waiver is intended to be as broad and inclusive as is permitted by the law of the State of Illinois and that if any provision of this Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Waiver Agreement and shall not affect the validity and enforceability of any remaining provisions.

Certification: By indicating my acceptance of this waiver agreement, I am affirming that I have legal capacity to execute a binding contract, and I read and understood this waiver agreement and fully understand its terms. If I am registering a child under the age of 18 or an incapacitated adult I represent and warrant that I am the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, I agree that the terms of this waiver agreement shall apply equally to all persons I registered. If registering a child under 13, I agree and consent to the collection of that child's information which is provided for the purposes of race registration and race administration not limited to being included in the display of race results and/or presentation of race awards. I acknowledge that I am signing the waiver agreement freely and voluntarily, and intend by my acceptance to be a complete and unconditional release of all liability to the greatest extent allowed by law.
